**ADDITIONAL APPROPRIATION ACT OF THE ADMINISTRATION:
HOUSE OF ASSEMBLY, 1985**

ACT

To appropriate an additional amount of money for the requirements of the Administration: House of Assembly during the financial year ending 31 March 1985.

BE IT ENACTED by the State President and the House of Assembly of the Republic of South Africa, as follows:—

Subject to the provisions of the Exchequer and Audit Act, 1975 (Act No. 66 of 1975), there is hereby appropriated for the requirements of the Administration: House of Assembly during the financial year ending 31 March 1985, as a charge to the Revenue Account for White Affairs, the additional amounts of money shown in column 1 of the Schedule. 5
