**ACT**

**To amend the Payment of Members of Parliament Act, 1974, so as to regulate further the deductions of amounts from the salaries and allowances of members of Parliament on account of absence from meetings.**

*(Afrikaans text signed by the State President.)  
(Assented to 10 July 1985.)*

**BE IT ENACTED** by the State President and the Parliament of the Republic of South Africa, as follows:—

Substitution of section 2 of Act 40 of 1974, as substituted by section 2 of Act 94 of 1984.

1. The following section is hereby substituted for section 2 of the Payment of Members of Parliament Act, 1974:
- “Deductions on account of absence.
2. (1) Subject to the provisions of subsections (2) and (3), there shall be deducted from the amount payable under the provisions of this Act to a member of Parliament (other than the Speaker, the Chairman of a House and a Leader of an Official Opposition in a House)—
- (a) the sum of R50 for every day on which he fails—
- (i) to attend either a meeting of the House of which he is a member or a meeting of the Houses in joint sitting, if on the day in question there is no meeting of a committee referred to in subparagraph (ii);
  - (ii) whether during a session of Parliament or when Parliament is prorogued, to attend a meeting of a committee of which he is a member and which consists of members of the said House or of members of all three Houses, or, where two or more such committees meet on the same day, to attend the meeting of at least one of them, if on the day in question there is no meeting of that House or of the Houses in joint sitting; or
  - (iii) to attend at least one such meeting, if on the day in question there are meetings of the said House or of the Houses in joint sitting and also of one or more committees referred to in subparagraph (ii); and
- (b) the sum of R25 for every day on which he attends a meeting of the said House or a meeting of the Houses in joint sitting, but fails to attend

**Tot wysiging van die Wet op die Betaling van Parlementslede, 1974, ten einde die aftrekking van bedrae van die salaris en toelaes van Parlementslede weens afwezigheid van vergaderings verder te reël.**

(Goedgekeur op 10 Julie 1985.)

**DAAR WORD BEPAAL** deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:—

1. Artikel 2 van die Wet op die Betaling van Parlementslede, 1974, word hierby deur die volgende artikel vervang:

- 5 "Aftrekings 2. (1) Behoudens die bepalings van subartikels (2) en weens afwezigheid. (3) word daar van die bedrag wat ingevolge die bepalings van hierdie Wet betaalbaar is aan 'n lid van die Parlement (behalwe die Speaker, die Voorsitter van 'n Huis en 'n Leier van 'n Amptelike Opposisie in 'n Huis)—
- 10 (a) die som van R50 afgetrek vir elke dag waarop hy versuim—
- 15 (i) om of 'n vergadering van die Huis waarvan hy 'n lid is of 'n vergadering van die Huise in gesamentlike sitting by te woon, indien daar op die betrokke dag geen vergadering van 'n komitee in subparagraaf (ii) vermeld, is nie;
- 20 (ii) hetsy gedurende 'n sessie van die Parlement of wanneer die Parlement geprorogeer is, om 'n vergadering van 'n komitee waarvan hy 'n lid is en wat uit lede van genoemde Huis of uit lede van al drie Huise bestaan, by te woon of, waar twee of meer sodanige komitees op dieselfde dag byeenkom, om die vergadering van minstens een van hulle by te woon, indien daar op die betrokke dag nie 'n vergadering van daardie Huis of van die Huise in gesamentlike sitting is nie; of
- 25 (iii) om minstens een sodanige vergadering by te woon, indien daar op die betrokke dag vergaderings van genoemde Huis of van die Huise in gesamentlike sitting en ook van een of meer komitees in subparagraaf (ii) vermeld, is; en
- 30 (b) die som van R25 afgetrek vir elke dag waarop hy 'n vergadering van genoemde Huis of 'n vergadering van die Huise in gesamentlike sitting by-

a meeting of a committee referred to in paragraph (a) (ii) which takes place on the same day, but not at the same time, as the meeting of the House or of the Houses in joint sitting, or, if there is more than one such committee meeting on the day in question, to attend at least one of them.

(2) For the purposes of subsection (1) a member of Parliament shall not be regarded as having attended a meeting of a committee unless he remained in attendance until the adjournment of the meeting or was excused from further attendance by the chairman of the committee before the adjournment.

(3) No deduction shall be made under subsection (1) on account of the failure of a member of Parliament—

(a) to attend any meeting referred to in that subsection, if his absence is due to—

(i) his illness or the summons or subpoena of a competent court (except a summons to answer a criminal charge upon which he is convicted);

(ii) the death or serious illness of his wife or his child, and such absence is condoned by the Speaker; or

(iii) his serving with the South African Defence Force, or with any other force or service established by or under the Defence Act, 1957 (Act No. 44 of 1957), while the Republic is at war;

(b) to attend a meeting of the House of which he is a member or a meeting of the Houses in joint sitting, in respect of any further period of absence—

(i) not exceeding 25 days during any session of Parliament in which the estimates of expenditure for the ordinary administrative services of any financial year are considered; and

(ii) not exceeding seven days during any other session of Parliament; or

(c) to attend a meeting of a committee referred to in that subsection, in respect of a further period of absence not exceeding one day out of every four days on which the committee in question meets when Parliament is prorogued or when all three Houses are adjourned for longer than 30 days during a session of Parliament.”.

2. This Act shall be called the Payment of Members of Parliament Amendment Act, 1985.

- 35                (iii) sy diens in die Suid-Afrikaanse Weermag, of in 'n ander mag of diens by of kragtens die Verdedigingswet, 1957 (Wet No. 44 van 1957), ingestel, terwyl die Republiek in oorlog betrokke is;
- 40                (b) om 'n vergadering van die Huis waarvan hy 'n lid is of 'n vergadering van die Huise in gesamentlike sitting by te woon, ten opsigte van 'n verdere tydperk van afwesigheid—
- 45                (i) van hoogstens 25 dae gedurende 'n sessie van die Parlement waarin die begroting van uitgawes vir die gewone administratiewe dienste van 'n boekjaar oorweeg word; en
- 50                (ii) van hoogstens sewe dae gedurende enige ander sessie van die Parlement; of
- (c) om 'n vergadering van 'n komitee in daardie subartikel vermeld, by te woon, ten opsigte van 'n verdere tydperk van afwesigheid van hoogstens een dag uit elke vier dae waarop die betrokke komitee byeenkom wanneer die Parlement geprorogeer is of wanneer al drie Huise langer as 30 dae gedurende 'n sessie van die Parlement verdaag is.”.
