Tot wysiging van die Wet op die Universiteit van Port Elizabeth, 1964.

Aanhef

NADEMAAL dit vir die beter administrasie van die Universiteit van Port Elizabeth dienstig is om die Wet op die Universiteit van Port Elizabeth, 1964 (Wet No. 1 van 1964) (hieronder die Hoofwet genoem), te wysig met die doel om sekere van die bevoegdhede van die Staatspresident oor te dra aan die Minister van Onderwys en Kultuur: Administrasie: Volksraad, en om die bepalinge met betrekking tot die samestelling van die raad van die Universiteit ten opsigte van die getal lede van die raad asook die persone en instansies wat lede van die raad kies, te wysig:

WORD DAAR DERHALWE BEPAAL deur die Staatspresident en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

Wysiging van artikel 1 van Wet 1 van 1964, soos gewysig deur artikel 1 van Wet 66 van 1969, artikel 1 van Wet 114 van 1976 en artikel 1 van Wet 86 van 1979

1. Artikel 1 van die Hoofwet word hierby gewysig deur die omskrywing van 5
"Minister" deur die volgende omskrywing te vervang:

"'Minister' die Minister van **[Nasionale Opvoeding]** Onderwys en Kultuur:
Administrasie: Volksraad;".

Wysiging van artikel 6 van Wet 1 van 1964

2. Artikel 6 van die Hoofwet word hierby gewysig deur subartikel (2) deur die 10
volgende subartikel te vervang:

"(2) Die kanselier beklee sy amp vir 'n termyn van tien jaar, tensy hy voor die verstryking van dié termyn sy bedanking skriftelik by die raad indien of deur die **[Staatspresident]** Minister, op versoek van die raad, afgesit word om 'n rede wat die **[Staatspresident]** Minister voldoende ag." 15

Wysiging van artikel 9 van Wet 1 van 1964, soos gewysig deur artikel 2 van Wet 31 van 1967, artikel 3 van Wet 66 van 1969, artikel 4 van Wet 114 van 1976, artikel 2 van Wet 86 van 1979 en artikel 3 van Wet 68 van 1983

ACT

To amend the University of Port Elizabeth Act, 1964.

(English text signed by the State President.)
(Assented to 14 September 1988.)

Preamble

WHEREAS for the better administration of the University of Port Elizabeth it is expedient to amend the University of Port Elizabeth Act, 1964 (Act No. 1 of 1964) (hereinafter referred to as the principal Act), so as to transfer certain of the State President's powers to the Minister of Education and Culture: Administration: House of Assembly, and so as to amend the provisions relating to the constitution of the council of the University with regard to the number of members of the council and the persons who and bodies which elect members of the council:

BE IT THEREFORE ENACTED by the State President and the House of Assembly of the Republic of South Africa, as follows:—

Amendment of section 1 of Act 1 of 1964, as amended by section 1 of Act 66 of 1969, section 1 of Act 114 of 1976 and section 1 of Act 86 of 1979

- 5 1. Section 1 of the principal Act is hereby amended by the substitution for the definition of "Minister" of the following definition:

"'Minister' means the Minister of **[National Education]** Education and Culture: Administration: House of Assembly;".

Amendment of section 6 of Act 1 of 1964

- 10 2. Section 6 of the principal Act is hereby amended by the substitution for subsection (2) of the following subsection:

15 "(2) The chancellor shall hold office for a period of ten years, unless before the expiry of such period he submits his resignation in writing to the council or is removed from office by the **[State President]** Minister at the request of the council, for any reason deemed sufficient by the **[State President]** Minister.".

Amendment of section 9 of Act 1 of 1964, as amended by section 2 of Act 31 of 1967, section 3 of Act 66 of 1969, section 4 of Act 114 of 1976, section 2 of Act 86 of 1979 and section 3 of Act 68 of 1983

- 20 3. Section 9 of the principal Act is hereby amended—
(a) by the substitution for paragraph (b) of subsection (1) of the following paragraph:

- “(b) behoudens die bepalings van subartikel (2), **[twee]** vier persone deur die konvokasie gekies **[of indien die getal lede daarvan eenmaal die getal duisend bereik het, drie persone aldus gekies]**,”;
- (b) deur paragraaf (c) van subartikel (1) deur die volgende paragraaf te vervang: 5
- “(c) vier persone deur die **[Staatspresident]** Minister aangestel,”;
- (c) deur paragraaf (i) van subartikel (1) deur die volgende paragraaf te vervang:
- “(i) een persoon gekies, soos by statuut voorgeskryf word, om die hoër skole **[in Oos-Kaapland]** wat in die statuut genoem word en waarin die 10 voertaal van die meerderheid van die leerlinge Afrikaans is, te verteenwoordig,”;
- (d) deur paragraaf (j) van subartikel (1) deur die volgende paragraaf te vervang:
- “(j) een persoon gekies, soos by statuut voorgeskryf word, om die hoër 15 skole **[in Oos-Kaapland]** wat in die statuut genoem word en waarin die voertaal van die meerderheid van die leerlinge Engels is, te verteenwoordig,”;
- (e) deur paragraaf (k) van subartikel (1) deur die volgende paragraaf te vervang: 20
- “(k) **[twee]** drie professore van die Universiteit deur die senaat gekies,”; en
- (f) deur paragraaf (l) van subartikel (1) deur die volgende paragraaf te vervang:
- “(l) een persoon **[gekies, soos by statuut voorgeskryf, deur die afdelingsrade in Oos-Kaapland]** aangestel deur die uitvoerende bestuur van die 25 Oos-Kaapse Landbou-unie.”.

Kort titel en inwerkingtreeding

4. (1) Hierdie Wet heet die Private Wysigingswet op die Universiteit van Port Elizabeth, 1988.

(2) Die bepalings van artikel 3 (f) van hierdie Wet tree in werking op 1 Januarie 30 van die jaar wat volg op die jaar waarin die laaste afdelingsraad in Oos-Kaapland opgehou het om te bestaan: Met dien verstande dat die dienstermyn van die lid van die raad wat ingevolge artikel 9 (1) (l) van die Hoofwet, soos dit gelui het voor die vervanging daarvan by artikel 3 (f) van hierdie Wet, deur die afdelingsrade gekies is, ondanks die bepalings van artikel 9 (3) van die Hoofwet eindig op 31 Desember van 35 die jaar waarin die laaste afdelingsraad in Oos-Kaapland opgehou het om te bestaan.

- “(b) subject to the provisions of subsection (2), **[two] four** persons elected by the convocation **[or if the number of members thereof has once reached the number of one thousand, three persons so elected]**.”;
- 5 (b) by the substitution for paragraph (c) of subsection (1) of the following paragraph:
- “(c) four persons appointed by the **[State President] Minister**.”;
- (c) by the substitution for paragraph (i) of subsection (1) of the following paragraph:
- 10 “(i) one person elected, in the manner prescribed by the statute, to represent the high schools **[in the Eastern Cape]** listed in the statute and in which the medium of instruction of the majority of the pupils is Afrikaans.”;
- (d) by the substitution for paragraph (j) of subsection (1) of the following paragraph:
- 15 “(j) one person elected, in the manner prescribed by the statute, to represent the high schools **[in the Eastern Cape]** listed in the statute and in which the medium of instruction of the majority of the pupils is English.”;
- (e) by the substitution for paragraph (k) of subsection (1) of the following paragraph:
- 20 “(k) **[two]** three professors of the University elected by the senate.”; and
- (f) by the substitution for paragraph (l) of subsection (1) of the following paragraph:
- 25 “(l) one person **[elected, in the manner prescribed by the statute, by the divisional councils in the Eastern Cape]** appointed by the executive of the East Cape Agricultural Union.”.

Short title and commencement

4. (1) This Act shall be called the University of Port Elizabeth (Private) Amendment Act, 1988.
- 30 (2) The provisions of section 3 (f) of this Act shall come into operation on 1 January of the year following on the year in which the last divisional council in the Eastern Cape ceased to exist: Provided that the term of office of the member of the council elected by the divisional councils in terms of section 9 (1) (l) of the principal Act, as it read before its substitution by section 3 (f) of this Act, shall, notwithstanding the provisions of section 9 (3) of the principal Act, terminate on
- 35 31 December of the year in which the last divisional council in the Eastern Cape ceased to exist.
