#### INTRODUCTION TO TSOGO SUN

Tsogo Sun is a Joint Venture company constituted between Tsogo Investments and Southern Sun Gaming to pursue opportunities in the South African casino industry. Each of Tsogo Investments and Southern Sun Gaming hold a 50% interest in Tsogo Sun. Tsogo Investments is a broad-based Black empowerment focused group whose shareholding benefits organised Black business and labour movements, together with Women's Groupings, Black business interests and individual promoters. This shareholding includes FABCOS, NAFCOC, NACTU and SACTWU. Southern Sun Gaming is a whollyowned subsidiary of Southern Sun Holdings, the leading southern African hotel Group which is in turn, wholly owned by SABMiller, a multinational brewing company.

Tsogo Sun has been awarded licences to operate casinos in Witbank and Nelspruit, Mpumalanga Province and at Fourways, Gauteng Province. An associate of Tsogo Sun named Tsogo Sun KwaZulu-Natal (Proprietary) Limited in which Tsogo Sun has a 33% indirect interest, has been licensed to operate a casino in Durban, KwaZulu-Natal Province and a second associate of Tsogo Sun named Tsogo Sun Emonti (Proprietary) Limited in which Tsogo Sun has a 60% direct interest has been licensed to operate a casino in East London, Eastern Cape Province.

#### 2. Guide on how to use the Act [Section 51(1)(b)]

The Promotion of Access to Information Act grants a requester access to records of a company, if the record is required for the exercise or protection of any rights. If a public body lodges a request, the public body must be acting in the public interest. Requests in terms of the Act are required to be made in accordance with the prescribed procedures, at the rates provided.

#### iii. The request procedure

To facilitate the processing of your request, kindly:

- Use the prescribed form.
- Address your request to the Head: Attention The Company Secretary at the address, facsimile number or electronic mail address of Tsogo Sun.

- Provide sufficient details to enable Tsogo Sun to identify:
  - (a) the record(s) requested;
  - (b) the requester (and if an agent is lodging the request, proof of capacity);
  - (c) the form of access required;
  - (d) (i) the postal address or facsimile number of the requester in the Republic;
    - ii) if the requester wishes to be informed of the decision in any manner (in addition to written) the manner and particular thereof;
  - (e) the right which the requester is seeking to exercise or protect with an explanation of the reason the record is required to exercise or protect the right.

#### iv. Prescribed Fees

The following applies to requests (other than personal requests):

- A requester is required to pay the prescribed fees (R50,00) before a request will be processed;
- If the preparation of the record requested requires more than the prescribed hours (six), a
  deposit shall be paid (of not more than one third of the access fee which would be payable
  if the request were granted);
- A requester may lodge an application with a court against the tender/payment of the request fee and/or deposit;
- · Records may be withheld until the fees have been paid.

#### 5. Other information as may be prescribed [Section 51(1)(f)]

The Minister of Justice and Constitutional Development has not made any Regulations in this regard.

### 6. Availability of the Manual [Section 51(3)]

This Manual is also available for inspection at the offices of Tsogo Sun free of charge and copies are available with the SAHRC, in the Gazette and on the website of the Department of Justice and Constitutional Development www.doj.gov.za — under Regulations.)

- (2) For purposes of section 54(2) of the Act, the following applies:
  - (a) Six hours as the hours to be exceeded before a deposit is payable; and
  - (b) one third of the access fee is payable as a deposit by the requester.
- (3) The actual postage is payable when a copy of a record must be posted to a requester.
