

- Everyone has the right to have access to adequate housing.
- The State must take reasonable legislative and other measures, within its available resources, to achieve the progressive realisation of this right.
- No one may be evicted from their home, or have their home demolished, without an order of Court made after consideration of all the relevant circumstances. No legislation may permit arbitrary evictions.

# G. DESCRIPTION OF THE GUIDE ON HOW TO USE THE PROMOTION OF ACCESS TO INFORMATION ACT, 2000 (ACT No. 2 OF 2000).

The Guide on how to use the Act, inter-alia include a description of:-

- (a) the objects of the Act;
- (b) the postal and street address, phone and fax number as well electronic mail address of
  - the information officer of the public body; and
  - the deputy information officer of the public body appointed in terms of section 17(1);
- (c) such particulars of every private body as are practicable;
- (d) the manner and form of a request for
  - access to a record of a public body contemplated in section 11; and
  - access to a record of a private body contemplated in section 50;
- the assistance available from the information officer of a public body in terms of the Act;
- (f) the assistance available from the Human Rights Commission in terms of the Act;
- (g) all remedies in law available regarding an act or failure to act in respect of a right or duty conferred or imposed by the Act, including the manner of lodging-
  - (i) an internal appeal; and
  - (iii) an application with a court against a decision by the information officer of a public body, a decision on internal appeal or a decision of the head of a private body;

- (h) the provisions of sections 14 and 51 requiring a public body and private body, respectively, to compile a manual, and how to obtain access to a manual;
- the provisions of sections 15 and 52 providing for the voluntary disclosure (i) of categories of records by a public body and private body, respectively;
- (j) the notices issued in terms of sections 22 and 54 regarding fees to be paid in relation to requests for access; and
- (k) the regulations made in terms of section 92.

# H. FACILITATION OF A REQUEST FOR ACCESS TO A RECORD OF A DEPARTMENT

Any person who wishes to obtain access to information held by the public body (Department) may access them by filing in the application form as prescribed in Government Notice No. R 187 of 15 February 2002.

#### I. RECORDS HELD BY THE DEPARTMENT

The Public body (Mpumalanga Department of Housing and Land Administration) holds the following records which could be requested in terms of the Act:

#### FINANCE

 Records related to Housing funds grants (conditional grants) and equitable share funds.

#### SUPPORT SERVICES

Records related to Departmental Human Resource Personnel and the public body's organogram.

#### LEGAL SERVICES

Records related to contractual documents signed with various Developers and contractors, as well as records related to or emanating from any legislative requirements e.g policy framework etc.

#### LAND ADMINISTRATION

- Records related to areas where Macro Planning and land surveying are conducted;
- Records related to areas where land reform is being managed; and
- Records related to areas where land development is being conducted.

#### HOUSING

 Records related to evaluation of housing subsidy applications, approvals, and monitoring of construction of Reconstruction and Development Process (R.D.P) Houses.

#### TECHNICAL SERVICES

Records related to areas where engineering services, architectural and quality surveying are being conducted.

# J. DESCRIPTION OF SERVICES AVAILABLE TO MEMBERS OF THE PUBLIC AND HOW TO GAIN ACCESS TO SUCH SERVICES

The following services are available to the General Public in Mpumalanga Province.

- Assistance with applications for Housing Subsidies in terms of different subsidy instruments such as:
  - Project linked subsidy;
  - Credit linked subsidy;
  - Individual subsidy;
  - Consolidated subsidy;
  - Rural subsidy;
  - Institutional subsidy; and
  - People's Housing Process.
