## TERMS OF ACCREDITATION FOR CONCILIATION

### 1. SCOPE OF ACCREDITATION

1.1 The Council is, in terms of Section 127(5) of the Labour Relations Act, No 66 of 1995 ("the Act"), as amended, accredited to conciliate the following:

- a) dispute about the interpretation or application of the provisions of Chapter II (section 9 of the Act);
- b) disputes that form the subject matter of a proposed strike or lockout (section 64(1) of the Act);
- c) disputes in essential services (section 74 of the Act);
- d) disputes about unfair dismissals (section 191 of the Act);
- e) disputes about entitlement to severance pay (section 41 (6) of the Basic Conditions of Employment Act 75 of 1997);
- f) disputes about unfair labour practices (section 186(2) of the Act).

### 2. POWERS OF ACCREDITATION

2.1 Only those persons who are accredited by the CCMA, or are part-time commissioners appointed by the Governing Body of the Commission in terms of section 117(2) of the Labour Relations Act, may perform the accreditation functions of the council for the Council.

2.2 The following provisions of the Act apply to Councils accredited for conciliation

- a) for the purpose of this paragraph, with the exclusion of section 143(3), in Part C of Chapter VII of the Act any reference to:

"Commission" must be read as a reference to the Council;  
"Commissioner" must read as a reference to a conciliator appointed by the Council and whose name is listed in the attached schedule;  
"Director" must be read as a reference to the Secretary of the Council.

- b) As prescribed by section 127(b) of the Act, the provisions of the sections contained in Part C of the Chapter VII to the Council in the performance of its accredited functions, subject to the provisions of the Council's Constitution or any other collective agreement concluded in the Council. For the purpose of this sub-paragraph the provisions of the following apply:

- (i) The provisions of sections 133 to 135;
- (ii) The provisions of section 142;
- (iii) The provisions of section 142 A; and
- (iv) The provisions of section 148.

### 2.3 Extension of the Period of Accreditation

Despite the expiry of the period stated in the Certificate of Accreditation, the Council may continue to perform its accreditation functions in respect of any dispute referred to it during the stated period, but not resolved by the time period expires, until that dispute is resolved.

### 3. Transgressions of terms of accreditation

If the accreditation Council fails to comply with the terms of their accreditation, the Governing Body of the Commission may revoke accreditation.

- h) disputes that form the subject matter of a proposed strike or lockout (section 64(1) of the Act);
- i) disputes in essential services (section 74 of the Act);
- j) disputes about unfair dismissals (section 191 of the Act);

- k) disputes about entitlement to severance pay (section 41 (6) of the Basic Conditions of Employment Act 75 of 1997);
- l) disputes about unfair labour practices (section 186(2) of the Act).

- 2.2 To arbitrate disputes referred to in paragraph (1.1) above, where these disputes remain unresolved after conciliation and the Council has jurisdiction to resolve them by way of arbitration in terms of the Act.

**NOTICE 1750 OF 2005****INTERNATIONAL TRADE ADMINISTRATION COMMISSION****NOTICE OF INITIATION OF A SUNSET REVIEW OF THE ANTI-DUMPING DUTIES ON GARLIC ORIGINATING IN OR IMPORTED FROM THE PEOPLES REPUBLIC OF CHINA**

In accordance with the provisions in Article 11.3 of the World Trade Organisation Agreement on the Implementation of Article VI of the General Agreement on Tariffs and Trade, any definitive duty shall be terminated on a date not later than five years from its imposition, unless the authorities determine, in a review initiated before that date on their own initiative or upon a duly substantiated request made by or on behalf of the domestic industry within a reasonable period of time prior to that date, that the expiry of the duty would be likely to lead to continuation or recurrence of dumping and injury.

On 28 May 2004, the International Trade Administration Commission (the Commission) notified all interested parties, through Notice No. 947 of Government Gazette No. 26374, that unless a request is made by or on behalf of the domestic industry for the duties to be reviewed prior to the expiry thereof, the anti-dumping duties on garlic originating in or imported from the People's Republic of China (PRC), will expire on 20 October 2005.

A duly completed Petition Review Questionnaire was submitted to the Commission on 4 May 2005.

**THE APPLICANT**

The application was lodged by the South African Garlic Growers Association, on behalf of the producers of the subject product in the SACU. The Applicant submitted sufficient evidence and established a *prima facie* case to enable the Commission to arrive at a reasonable conclusion that a review investigation should be initiated.

## **THE PRODUCT**

The product under investigation (subject product) is garlic, which is classifiable under tariff subheading 0703.20 originating in or imported from the PRC.

## **THE ALLEGATION OF THE CONTINUATION OR RECURRENCE OF DUMPING**

The allegation of continuation or recurrence of dumping is based on a comparison between the normal values and export prices. The normal values were based on information obtained by the Applicant in Argentina, which was nominated as the surrogate country for the People's Republic of China, and is the second biggest exporter of garlic in the world after the People's Republic of China. The export prices from the PRC were based on statistics from SARS. On this basis, the Commission found that there was *prima facie* proof of the likely recurrence of dumping if the duties expire, with regard to exports from the PRC.

## **THE ALLEGATION OF THE CONTINUATION OR RECURRENCE OF MATERIAL INJURY**

The Applicant alleges and submitted sufficient evidence to show that there is price undercutting and that the prices of the imports in question are depressing and suppressing its selling prices. The Applicant's information indicated that it will experience a decline in sales, a decline in profit margins, and a decline in return on investment, if the duties expire. It was also indicated that the Applicant's market will decrease at the expense of a corresponding increase in the market share of the dumped goods, if the duties expire. On this basis, the Commission found that there was *prima facie* proof of the continuation and/or recurrence of material injury.

## **PERIOD OF INVESTIGATION**

The period of investigation for purposes of determining the continuation or recurrence of dumping from the exporting countries of origin will be from 1 January 2004 to 31 December 2004. The period of investigation for purposes of determining continuation or recurrence of injury will be from 1 January 2001 to 31 December

2004. The Commission will also consider an assumption of what the situation will be, if the duties expire. If there are subsequent events that are relevant to injury the Commission may later request and consider further, more recent information.

## **PROCEDURAL FRAMEWORK**

Having decided that there is sufficient evidence and a *prima facie* case to justify the initiation of an investigation, the Commission has begun an investigation in terms of section 16 of the International Trade Administration Act, 2002 (the ITA Act). The Commission will conduct its investigation in accordance with the relevant sections of the ITA Act, the World Trade Organisation Agreement on Implementation of Article VI of the GATT 1994 (the Anti-Dumping Agreement) and the Anti-Dumping Regulations of the International Trade Administration Commission of South Africa (ADR). Both the ITA Act and the ADR are available on the Commission's website ([www.itac.org.za](http://www.itac.org.za)) or from the Trade Remedies section, on request.

In order to obtain the information it deems necessary for its investigation, the Commission will send non-confidential versions of the petition and questionnaires to all known importers and exporters, and known representative associations. The trade representative of the exporting country have also been notified. Importers and other interested parties are invited to contact the Commission as soon as possible in order to determine whether they have been listed and were furnished with the relevant documentation. If not, they should immediately ensure that they are sent copies. The questionnaire has to be completed and any other representations must be made within the time limit set out below.

## **CONFIDENTIAL INFORMATION**

Please note that if any information is considered to be confidential then a non-confidential version of the information must be submitted for the public file, simultaneously with the confidential version. In submitting a non-confidential version the following rules are strictly applicable and parties must indicate:

↳ where confidential information has been omitted and the nature of such

- information;
- ☞ reasons for such confidentiality;
- ☞ a summary of the confidential information which permits a reasonable understanding of the substance of the confidential information; and
- ☞ in exceptional cases, where information is not susceptible to summary, reasons must be submitted to this effect.

This rule applies to all parties and to all correspondence with and submissions to the Commission, which unless indicated to be confidential and filed together with a non-confidential version, will be placed on the public file and be made available to other interested parties.

If a party considers that any document of another party, on which that party is submitting representations, does not comply with the above rules and that such deficiency affects that party's ability to make meaningful representations, the details of the deficiency and the reasons why that party's rights are so affected must be submitted to the Commission in writing forthwith (and at the latest 14 days prior to the date on which that party's submission is due). Failure to do so timeously, will seriously hamper the proper administration of the investigation, and such party will not be able to subsequently claim an inability to make meaningful representations on the basis of the failure of such other party to meet the requirements.

Subsection 33(1) of the ITA Act provides that any person claiming confidentiality of information should identify whether such information is *confidential by nature* or is *otherwise confidential* and, any such claims must be supported by a written statement, in each case, setting out how the information satisfies the requirements of the claim to confidentiality. In the alternative, a sworn statement should be made setting out reasons why it is impossible to comply with these requirements.

Section 2.3 of the ADR provides as follows:

## PROCEDURES AND TIME LIMITS

All responses, including non-confidential copies of the responses, should be received by the Director: Trade Remedies not later than 30 days from the date hereof, or from the date on which the letter accompanying the abovementioned questionnaire was received.
