HIGH ALERT: SCAM WARNING!!!

TO ALL SUPPLIERS AND SERVICE PROVIDERS OF THE GOVERNMENT PRINTING WORKS

It has come to the attention of the *GOVERNMENT PRINTING WORKS* that there are certain unscrupulous companies and individuals who are defrauding unsuspecting businesses disguised as representatives of the *Government Printing Works (GPW)*.

The scam involves the fraudsters using the letterhead of *GPW* to send out fake tender bids to companies and requests to supply equipment and goods.

Although the contact person's name on the letter may be of an existing official, the contact details on the letter are not the same as the *Government Printing Works*. When searching on the Internet for the address of the company that has sent the fake tender document, the address does not exist.

The banking details are in a private name and not company name. Government will never ask you to deposit any funds for any business transaction. *GPW* has alerted the relevant law enforcement authorities to investigate this scam to protect legitimate businesses as well as the name of the organisation.

Example of e-mails these fraudsters are using:

PROCUREMENT@GPW-GOV.ORG

Should you suspect that you are a victim of a scam, you must urgently contact the police and inform the *GPW*.

GPW has an official email with the domain as [@gpw.gov.za](mailto:GPW@gpw.gov.za)

Government e-mails DO NOT have org in their e-mail addresses. All of these fraudsters also use the same or very similar telephone numbers. Although such number with an area code 012 looks like a landline, it is not fixed to any property.

GPW will never send you an e-mail asking you to supply equipment and goods without a purchase/order number. *GPW* does not procure goods for another level of Government. The organisation will not be liable for actions that result in companies or individuals being resultant victims of such a scam.

Government Printing Works gives businesses the opportunity to supply goods and services through RFQ / Tendering process. In order to be eligible to bid to provide goods and services, suppliers must be registered on the National Treasury's Central Supplier Database (CSD). To be registered, they must meet all current legislative requirements (e.g. have a valid tax clearance certificate and be in good standing with the South African Revenue Services - SARS).

The tender process is managed through the Supply Chain Management (SCM) system of the department. SCM is highly regulated to minimise the risk of fraud, and to meet objectives which include value for money, open and effective competition, equitability, accountability, fair dealing, transparency and an ethical approach. Relevant legislation, regulations, policies, guidelines and instructions can be found on the tender's website.

Fake Tenders

National Treasury's CSD has launched the Government Order Scam campaign to combat fraudulent requests for quotes (RFQs). Such fraudulent requests have resulted in innocent companies losing money. We work hard at preventing and fighting fraud, but criminal activity is always a risk.

How tender scams work

There are many types of tender scams. Here are some of the more frequent scenarios:

Fraudsters use what appears to be government department stationery with fictitious logos and contact details to send a fake RFQ to a company to invite it to urgently supply goods. Shortly after the company has submitted its quote, it receives notification that it has won the tender. The company delivers the goods to someone who poses as an official or at a fake site. The Department has no idea of this transaction made in its name. The company is then never paid and suffers a loss.

OR

Fraudsters use what appears to be government department stationery with fictitious logos and contact details to send a fake RFQ to Company A to invite it to urgently supply goods. Typically, the tender specification is so unique that only Company B (a fictitious company created by the fraudster) can supply the goods in question.

Shortly after Company A has submitted its quote it receives notification that it has won the tender. Company A orders the goods and pays a deposit to the fictitious Company B. Once Company B receives the money, it disappears. Company A's money is stolen in the process.

Protect yourself from being scammed

- If you are registered on the supplier databases and you receive a request to tender or quote that seems to be from a government department, contact the department to confirm that the request is legitimate. Do not use the contact details on the tender document as these might be fraudulent.
- Compare tender details with those that appear in the Tender Bulletin, available online at www.gpwonline.co.za
- Make sure you familiarise yourself with how government procures goods and services. Visit the tender website for more information on how to tender.
- If you are uncomfortable about the request received, consider visiting the government department and/or the place of delivery and/or the service provider from whom you will be sourcing the goods.
- In the unlikely event that you are asked for a deposit to make a bid, contact the SCM unit of the department in question to ask whether this is in fact correct.

GOVERNMENT PRINTING WORKS - BUSINESS RULES

The **Government Printing Works (GPW)** has established rules for submitting notices in line with its electronic notice processing system, which requires the use of electronic *Adobe Forms*. Please ensure that you adhere to these guidelines when completing and submitting your notice submission.

CLOSING TIMES FOR ACCEPTANCE OF NOTICES

1. The *Government Gazette* and *Government Tender Bulletin* are weekly publications that are published on Fridays and the closing time for the acceptance of notices is strictly applied according to the scheduled time for each gazette.
2. Please refer to the Submission Notice Deadline schedule in the table below. This schedule is also published online on the Government Printing works website www.gpwonline.co.za

All re-submissions will be subject to the standard cut-off times.

All notices received after the closing time will be rejected.

EXTRAORDINARY GAZETTES

3. *Extraordinary Gazettes* can have only one publication date. If multiple publications of an *Extraordinary Gazette* are required, a separate Z95/Z95Prov *Adobe* Forms for each publication date must be submitted.

NOTICE SUBMISSION PROCESS

4. Download the latest *Adobe* form, for the relevant notice to be placed, from the **Government Printing Works** website www.gpwonline.co.za.
5. The *Adobe* form needs to be completed electronically using *Adobe Acrobat / Acrobat Reader*. Only electronically completed *Adobe* forms will be accepted. No printed, handwritten and/or scanned *Adobe* forms will be accepted.
6. The completed electronic *Adobe* form has to be submitted via email to submit.egazette@gpw.gov.za. The form needs to be submitted in its original electronic *Adobe* format to enable the system to extract the completed information from the form for placement in the publication.
7. Every notice submitted **must** be accompanied by an official **GPW** quotation. This must be obtained from the *eGazette* Contact Centre.
8. Each notice submission should be sent as a single email. The email **must** contain **all documentation relating to a particular notice submission**.
 - 8.1. Each of the following documents must be attached to the email as a separate attachment:
 - 8.1.1. An electronically completed *Adobe* form, specific to the type of notice that is to be placed.
 - 8.1.1.1. For *National Government Gazette* or *Provincial Gazette* notices, the notices must be accompanied by an electronic Z95 or Z95Prov *Adobe* form
 - 8.1.1.2. The notice content (body copy) **MUST** be a separate attachment.
 - 8.1.2. A copy of the official **Government Printing Works** quotation you received for your notice. (*Please see Quotation section below for further details*)
 - 8.1.3. A valid and legible Proof of Payment / Purchase Order: **Government Printing Works** account customer must include a copy of their Purchase Order. **Non-Government Printing Works** account customer needs to submit the proof of payment for the notice
 - 8.1.4. Where separate notice content is applicable (Z95, Z95 Prov and TForm 3, it should **also** be attached as a separate attachment. (*Please see the Copy Section below, for the specifications*).
 - 8.1.5. Any additional notice information if applicable.

GOVERNMENT PRINTING WORKS - BUSINESS RULES

9. The electronic *Adobe* form will be taken as the primary source for the notice information to be published. Instructions that are on the email body or covering letter that contradicts the notice form content will not be considered. The information submitted on the electronic *Adobe* form will be published as-is.
10. To avoid duplicated publication of the same notice and double billing, Please submit your notice **ONLY ONCE**.
11. Notices brought to **GPW** by “walk-in” customers on electronic media can only be submitted in *Adobe* electronic form format. All “walk-in” customers with notices that are not on electronic *Adobe* forms will be routed to the Contact Centre where they will be assisted to complete the forms in the required format.
12. Should a customer submit a bulk submission of hard copy notices delivered by a messenger on behalf of any organisation e.g. newspaper publisher, the messenger will be referred back to the sender as the submission does not adhere to the submission rules.

QUOTATIONS

13. Quotations are valid until the next tariff change.
 - 13.1. **Take note:** **GPW**'s annual tariff increase takes place on **1 April** therefore any quotations issued, accepted and submitted for publication up to **31 March** will keep the old tariff. For notices to be published from 1 April, a quotation must be obtained from **GPW** with the new tariffs. Where a tariff increase is implemented during the year, **GPW** endeavours to provide customers with 30 days' notice of such changes.
14. Each quotation has a unique number.
15. Form Content notices must be emailed to the *eGazette* Contact Centre for a quotation.
 - 15.1. The *Adobe* form supplied is uploaded by the Contact Centre Agent and the system automatically calculates the cost of your notice based on the layout/format of the content supplied.
 - 15.2. It is critical that these *Adobe* Forms are completed correctly and adhere to the guidelines as stipulated by **GPW**.
16. **APPLICABLE ONLY TO GPW ACCOUNT HOLDERS:**
 - 16.1. **GPW** Account Customers must provide a valid **GPW** account number to obtain a quotation.
 - 16.2. Accounts for **GPW** account customers **must** be active with sufficient credit to transact with **GPW** to submit notices.
 - 16.2.1. If you are unsure about or need to resolve the status of your account, please contact the **GPW** Finance Department prior to submitting your notices. (If the account status is not resolved prior to submission of your notice, the notice will be failed during the process).
17. **APPLICABLE ONLY TO CASH CUSTOMERS:**
 - 17.1. Cash customers doing **bulk payments** must use a **single email address** in order to use the **same proof of payment** for submitting multiple notices.
18. The responsibility lies with you, the customer, to ensure that the payment made for your notice(s) to be published is sufficient to cover the cost of the notice(s).
19. Each quotation will be associated with one proof of payment / purchase order / cash receipt.
 - 19.1. This means that **the quotation number can only be used once to make a payment.**

GOVERNMENT PRINTING WORKS - BUSINESS RULES**COPY (SEPARATE NOTICE CONTENT DOCUMENT)**

20. Where the copy is part of a separate attachment document for Z95, Z95Prov and TForm03
- 20.1. Copy of notices must be supplied in a separate document and may not constitute part of any covering letter, purchase order, proof of payment or other attached documents.
- The content document should contain only one notice. (You may include the different translations of the same notice in the same document).
- 20.2. The notice should be set on an A4 page, with margins and fonts set as follows:
- Page size = A4 Portrait with page margins: Top = 40mm, LH/RH = 16mm, Bottom = 40mm;
Use font size: Arial or Helvetica 10pt with 11pt line spacing;
- Page size = A4 Landscape with page margins: Top = 16mm, LH/RH = 40mm, Bottom = 16mm;
Use font size: Arial or Helvetica 10pt with 11pt line spacing;

CANCELLATIONS

21. Cancellation of notice submissions are accepted by **GPW** according to the deadlines stated in the table above in point 2. Non-compliance to these deadlines will result in your request being failed. Please pay special attention to the different deadlines for each gazette. Please note that any notices cancelled after the cancellation deadline will be published and charged at full cost.
22. Requests for cancellation must be sent by the original sender of the notice and must be accompanied by the relevant notice reference number (N-) in the email body.

AMENDMENTS TO NOTICES

23. With effect from 01 October 2015, **GPW** will not longer accept amendments to notices. The cancellation process will need to be followed according to the deadline and a new notice submitted thereafter for the next available publication date.

REJECTIONS

24. All notices not meeting the submission rules will be rejected to the customer to be corrected and resubmitted. Assistance will be available through the Contact Centre should help be required when completing the forms. (012-748 6200 or email info.egazette@gpw.gov.za). Reasons for rejections include the following:
- 24.1. Incorrectly completed forms and notices submitted in the wrong format, will be rejected.
- 24.2. Any notice submissions not on the correct *Adobe* electronic form, will be rejected.
- 24.3. Any notice submissions not accompanied by the proof of payment / purchase order will be rejected and the notice will not be processed.
- 24.4. Any submissions or re-submissions that miss the submission cut-off times will be rejected to the customer. The Notice needs to be re-submitted with a new publication date.

GOVERNMENT PRINTING WORKS - BUSINESS RULES**APPROVAL OF NOTICES**

25. Any notices other than legal notices are subject to the approval of the Government Printer, who may refuse acceptance or further publication of any notice.
26. No amendments will be accepted in respect to separate notice content that was sent with a Z95 or Z95Prov notice submissions. The copy of notice in layout format (previously known as proof-out) is only provided where requested, for Advertiser to see the notice in final Gazette layout. Should they find that the information submitted was incorrect, they should request for a notice cancellation and resubmit the corrected notice, subject to standard submission deadlines. The cancellation is also subject to the stages in the publishing process, i.e. If cancellation is received when production (printing process) has commenced, then the notice cannot be cancelled.

GOVERNMENT PRINTER INDEMNIFIED AGAINST LIABILITY

27. The Government Printer will assume no liability in respect of—
 - 27.1. any delay in the publication of a notice or publication of such notice on any date other than that stipulated by the advertiser;
 - 27.2. erroneous classification of a notice, or the placement of such notice in any section or under any heading other than the section or heading stipulated by the advertiser;
 - 27.3. any editing, revision, omission, typographical errors or errors resulting from faint or indistinct copy.

LIABILITY OF ADVERTISER

28. Advertisers will be held liable for any compensation and costs arising from any action which may be instituted against the Government Printer in consequence of the publication of any notice.

CUSTOMER INQUIRIES

Many of our customers request immediate feedback/confirmation of notice placement in the gazette from our Contact Centre once they have submitted their notice – While **GPW** deems it one of their highest priorities and responsibilities to provide customers with this requested feedback and the best service at all times, we are only able to do so once we have started processing your notice submission.

SCHEDULE

Definitions

1. In these regulations, any word or expression to which a meaning has been assigned in the Act shall bear such meaning, unless the context indicates otherwise: –

Names that may not be used

2. A person who is not registered as a dietitian or nutritionist in terms of section 17 of the Act shall not use the expression:
 - (a) dietitian;

 - (e) diet(ary) adviser;
 - (f) diet(ary) counsellor;
 - (g) diet(ary) specialist;

 - (i) diet(ary) technician;
 - (j) diet(ary) coach,
 - (k) diet(ary) expert,
 - (l) diet(ary) fundi,
 - (m) diet(ary) guru,
 - (n) nutritionist;
 - (o) nutritional therapist;
 - (p) nutrition(al) specialist;

- (q) nutrition(al) adviser;
- (r) nutrition(al) educator;
- (s) nutrition(al) consultant;
- (t) nutrition(al) technician;
- (u) nutrition(al) coach,
- (v) nutrition(al) expert,
- (w) nutrition(al) fundi,
- (x) nutrition(al) guru and;
- (y) any similar appellation, derivative, or similar word or phrase.

Repeal

3. The Regulations Relating to the Use of Certain Names only by Registered Dietitians published under Government Notice No.3562 in *Government Gazette* 48838 of 23 June 2023, and the Regulations Relating to the Use of Certain Names only by Registered Dietitians published under Government Notice No. 1104 in *Government Gazette* 9242 of 30 May 1984 are hereby repealed.

4. **Short title**

The last date of enrolment on the NATED N1 - N3 programmes is **31 December 2023**.

Stakeholder feedback, research reports and curriculum evaluations have repeatedly indicated that the curriculum structure, design and content of the NATED N1 – N3 programmes have become outdated and do not sufficiently align with other qualifications on the National Qualifications Framework (NQF).

Trade Test regulations

In May 2015 the then Minister of Higher Education and Training published Trade Test regulations in Gazette 38758 after consulting with the National Skills Authority (NSA) and the Quality Council for Trades and Occupations (QCTO). These trade test regulations highlight the following:

- An Artisan qualification is defined as an “occupational qualification approved by the Minister for the purpose of certifying a person as an artisan”.
- Curriculum components of an artisan qualification means the knowledge, practical and structured work experience components of a curriculum.

The transitional arrangements regulation (regulation 11) indicates that:

(1) A trade test centre accredited by a SETA prior to the commencement of these regulations for a trade occupational qualification not registered on the National Qualifications Framework will be deemed to be accredited by the QCTO until the occupational qualification is registered.

(2) A trade test centre must apply to NAMB for a trade test serial number before allowing a candidate to proceed for a trade test unless NAMB gives approval for the trade test centre to conduct trade tests without applying for a trade test serial number.

(3) Until the QCTO determines the entrance requirements contemplated in regulation 2(2)(b) the minimum level of education for access to a trade test will be the successful achievement by a learner before, during or after an artisan learning programme of:

- a) N2 Certificate including the four relevant subjects of maths, engineering science and a fourth subject as required by the trade; or
- b) Technical trade theory programs quality assured by a SETA deemed to be equivalent to NQF level 3; or
- c) Relevant Engineering NCV Certificate with seven subjects at NQF level 3; or
- d) Technical Grade 11 with Maths, Science, Language and related trade theory subject; or
- e) Relevant (directly related to the trade theory subjects) N6 certificate or National Technical Diploma (T, S or N stream.)

In addition to the above mentioned minimum level of educational qualification the applicant must also have:

a) successfully completed all off the job practical training unit standards (in the case of learnerships) or modules (in the case of an apprenticeship) of an artisan learning program at an accredited training provider as verifiable by training records.

b) satisfied the requirements of the structured workplace, on the job, learning for a minimum period of 12 months verifiable through a workplace learning record (e.g logbook) unless any other workplace period has been contractually specified before the date of publication of this Regulation .

(4) The minimum level of knowledge for recognition of prior learning referred to in regulation 2(3) is a 50% pass in a written knowledge assessment that is an integral part of a recognition of prior learning toolkit approved by NAMB.

(5) Until such time as the occupational curricula and /or RPL toolkits for a specific trade are developed, candidates who have not gone through a formal artisan learning program but possess relevant years of work experience in the related trade may be granted access to a trade test if they have completed:

(a) N2 Certificate including the relevant trade theory subjects and a minimum of 3 years relevant work experience; or

(b) Technical trade theory programs quality assured by a SETA deemed to be at NQF level 3 and a minimum of 3 years relevant work experience; or

(c) Relevant Engineering NCV at NQF level 3 and a minimum of 3 years relevant work experience; or

(d) Relevant engineering NC(V) 4 plus completion of all relevant work experience modules and a minimum of 18-months relevant work experience; or

(e) Technical Grade 12 with Maths, Science and related trade theory subject and a minimum of 3 years relevant work experience; or

(f) Grade 9 and a minimum of 4 years relevant work experience; or

(g) Relevant (directly related to the trade theory subjects) N6 certificate or National Technical Diploma (T,S or N stream.) with 18 months relevant work experience.

The DHET published the list of 125 trades through Gazette No.35625 on 31 August 2012. The full list of trades will be developed into occupational qualifications which will be offered at TVET Colleges guided by industry within the footprint of the TVET College. This will ensure fit for purpose programme qualifications mix as well as differentiate each TVET College.

TVET Colleges currently offer 13 (thirteen) Occupational Qualifications which are registered on the NQF. The 13 (thirteen) are as follows:

Repeal of policy and transitional arrangements for the National Senior Certificate (Colleges) Programmes NATED Report 190/191

In April 2019, Umalusi, the Quality Council for General and Further Education and Training Sub-framework published a *repeal of policy and transitional arrangements for the National Senior Certificate (Colleges) Programmes NATED Report 190/191* in *gazette 42380*. The implications of the phase out of NSC (Colleges) by Umalusi are the following:

- N3 Engineering subjects cannot be combined with two (2) Business languages (Business English & Sake Afrikaans) to obtain an equivalent of the NSC with effect from 01 January 2021.
- N3 subjects cannot be combined with Senior Certificate subjects to obtain a Senior Certificate with effect from 01 January 2021.
- The last date of examination of the two (2) Business languages subjects was November 2020

Ministerial determination of the Sub-frameworks

In the Ministerial determination of the sub-frameworks that comprise the National Qualifications Framework (NQF) which was published in December 2020 in *Gazette 44031*, the following dates are provided in respect of the NATED programmes:

- Registration end date for pre-2009 qualifications and unit standards registered on the Occupational Qualifications Sub Framework (OQSF) and General and Further Education and Training Qualifications Sub Framework (GFETQSF) is 30 June 2023.
- The last date of first-time learners enrolling for pre-2009 qualifications and unit standards registered on the OQSF and GFETQSF is 30 June 2024.
- The last date of achievement for pre-2009 qualifications on the GFETQSF is 30 June 2025
- The last date of achievement for pre-2009 qualifications on the OQSF is 30 June 2027.

Pre-2009 qualifications referred to in this determination include NATED Report 191 programmes.

Government Notice for public comments

With the developments brought about by the publishing of the *trade test regulations 2014*, Umalusi's *repeal of the policy and transitional arrangements for the National Senior Certificate (Colleges) Programmes NATED Report 190/191 2019* and the *ministerial determination of the NQF sub frameworks 2020*, the DHET published in November 2020, a Government Notice for public comments in gazette 43872.

This Government Notice sought to provide the public with an opportunity to comment on the proposed changes to TVET Colleges programmes. These changes included the proposed phase out of NATED Report 191 N1 - N3 programmes. Comments were received from the public and other stakeholders including, TVET Colleges, Private Institutions, Quality Councils (Umalusi and the Quality Council for Trade and Occupations (QCTO)), academics, employers, employer organisations and others until April 2021. The analysis of the received comments revealed an overwhelming support for the phase out of N1 - N3 programmes.

Approval of phase out of NATED N1 - N3 programmes

In September 2021, the Minister of Higher Education Science and Innovation approved the phase out of NATED N1 – N3 programmes together with the establishment and terms of reference of a task team to oversee the planning and implementation of the phase out. The NATED N1-N3 Phase Out Task Team (NPOTT) was then established in February 2022.

Transitional arrangements

With the phase out of N1 – N3 programmes, there is a need to retain some of the N1 – N3 subjects which currently serve purposes for which there are no alternatives. These subjects will be retained in the interim for non-qualification purposes i.e. learners who complete these subjects will receive statements of results from the DHET.

Subjects retained for articulation into the NATED N4 Engineering Studies and other Engineering programmes

The following subjects will continue to be offered for the purposes of providing articulation and as a second chance to learners who have completed the National Senior Certificate (NSC) and would like to pursue studies towards N4 Engineering studies but did not meet the performance level required for admission:

- Mathematics N1, N2 and N3
- Engineering Science N1, N2 and N3
- Engineering Drawing N1, N2 and N3

Only students who have passed the NSC / Grade 12 may be allowed to complete these subjects for articulation purposes.

Subjects retained for trades that do not have occupational qualifications developed yet.

The following subjects will continue to be available for the purposes of providing access to artisanal training in those trades that currently do not have occupational qualifications and trade tests developed:

Employees who are sent to improve their knowledge by their employers or as part of their development in the workplace will also be allowed to enroll in the above subjects.

The flexibility brought by the N1, N2 and N3 programmes for the employed learner(s) is essential, where employed learners can enroll on these programmes per trimester sporadically. This will be retained by skills programmes that will cover module groups for registered occupational qualifications. Subjects will be replaced by skills programmes in accordance with the Occupational Qualification Sub Framework.

The retained NATED N1 – N3 subjects will be prioritised for realignment to skills programmes or part qualifications for the purpose of articulation, providing access to artisanal training and providing foundational learning to engineering related Occupational Qualifications. The naming convention shall be retained to eliminate confusion, and to encourage articulation as well as parity of esteem with phased out NATED programmes e.g skills programmes replacing Engineering Science N1, N2 and N3 should be Engineering Science N1 Skills Programme, Engineering Science N2 Skills Programme etc.

To amend the Local Government: Municipal Structures Act, 1998, so as to limit the frequency in terms of which a motion to remove a speaker from office may be tabled; to provide for circumstances when tabling of a motion for the removal of a speaker from office will not be limited; to limit the frequency in terms of which a motion to remove a whip from office may be tabled; to provide for circumstances when tabling of a motion for the removal of a whip from office will not be limited; to limit the frequency in terms of which a motion to remove an executive mayor or deputy executive mayor from office may be tabled; to provide for circumstances when tabling of a motion for the removal of an executive mayor or deputy executive mayor from office will not be limited; to provide a municipal council to make rules to regulate the appointment of an independent panel to determine the validity of a motion to remove a speaker, a whip, an executive mayor or an executive deputy mayor from office; and to provide for matters connected therewith.

BE IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

Amendment of section 40 of Act 117 of 1998

1. Section 40 of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998) (hereinafter referred to as the “principal Act”), is hereby amended by the

 - (c) an inability to perform the functions of office.
- (5) When a motion contemplated in subsection (2) or (4) is in order, the speaker must immediately refer the motion to an independent panel established for the purposes of considering the preliminary validity of the motion.
- (6) A municipal council must make rules to regulate the establishment and appointment of the panel referred to in subsection (5).”.

Amendment of section 41E of Act 117 of 1998 as inserted by section 19 of Act 3 of 2021

2. Section 41E of the principal Act is hereby amended by the addition of the following subsections:

- “(3) A notice of intention to move a motion for the removal of the whip may only be tabled once in a period of 12 months.

(4) Notwithstanding subsection (3), a motion contemplated to in subsection (2) may be tabled where the grounds for removal from office are as a result of—

(a) a violation of the Constitution or the law;

(b) misconduct; or

(c) inability to perform the functions of office.

MEMORANDUM ON THE OBJECTS OF THE LOCAL GOVERNMENT: MUNICIPAL STRUCTURES AMENDMENT BILL, 2023

1. INTRODUCTION

- 1.1 South Africa is currently in a transitional phase where the ruling party no longer holds majorities in a number of metros or councils across South Africa. With the 2024 National Elections around the corner, these elections are poised to be the first instance where the ruling party will slip below 50% of the votes. What this means for South Africa is that coalition governments will now be the “new norm”. Political parties and Independent Candidates will have to come together and form workable coalitions for the good of South Africa.
- 1.2 However, what we have witnessed at municipal level are continuous political attacks on coalition governments from opposition parties who politick smaller parties to cross the floor in exchange for valuable Mayoral Committee positions should the current government be successfully removed by way of a motion of no confidence. What we see in practice is motions of no confidence being used as a political tool, rather than for the mechanism it was originally intended, being a process to remove a speaker or mayor from office due to them not fulfilling their duties adequately. In fact, these motions are brought on spurious grounds only because the opposition coalition has 50% +1 of the votes to pass the motion. The result is that these motions make cities or municipalities ungovernable as a new Executive is installed every other month, not allowing the incumbent government enough time to actually make a difference.
- 1.3 There can be no question that this practice will continue which has, and will continue to have, a disastrous impact on the stability and running of a municipality. What needs to change is simple – there needs to be a limitation on the number of motions of no confidence that are allowed to be brought in a certain time frame. This will, at the very least, give the relevant government an uninterrupted period in which to perform or steady the province.

To amend the Preferential Procurement Policy Framework Act, 2000, so as to delete obsolete Roman numberings and to add a definition; to delete the obligation on an organ of state to follow a preferential point system when determining its preferential procurement policy and to replace it with a discretionary power; to delete the references to the maximum amount of points that may be allocated in instances where either a contract has a Rand value above, equal or below a prescribed amount; to provide that the achievement of specific goals may constitute a tiebreaker mechanism or constitute a maximum of 10 or 20 points, depending on the circumstances; to repeal the reference to what the specific goals may include and to replace it with the utilisation of Sustainable Development Goals as a framework for the implementation of the procurement policy contemplated in section 217(2) of the Constitution; to delete the option that specific goals may include the implementation of the Reconstruction and Development Programme; to substitute the Minister's discretion to make regulations with an obligation to do so, including to clarify the framework of utilising Sustainable Development Goals; to provide that draft regulations must be submitted to the National Assembly; to repeal the Broad-Based Black Economic Empowerment Act, 2003 as well as references to that Act wherever it appears in other legislation; to provide for transitional arrangements to deal with the repeal of the Broad-Based Blank Economic Empowerment Act and to provide for matters connected therewith.

BE IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

Amendment of section 2 of Act 5 of 2000

1. Section 1 of the Preferential Procurement Policy Framework Act, 2000 (hereinafter referred to as the “principal Act”), is hereby amended—

- (a) by the deletion of the Roman numerals before and after each definition; and
- (b) by the insertion after the definition of “prescribed” of the following definition:
““Sustainable Development Goals” means the goals referred to in section 2(1)(d); and”.

2. Section 2 of the principal Act is hereby amended—

- (a) by the substitution in subsection (1) for paragraphs (a) and (b) of the following paragraphs:

“(a) A preference point system **[must]** may be followed;

(b) (i) for contracts with a Rand value above a prescribed amount **[a maximum of 10 points may be allocated for specific goals as contemplated in paragraph (d)]** the achievement of specific goals as outlined in paragraph (d) may constitute a tiebreaker mechanism or constitute a maximum of 10 points [provided]; Provided that the lowest acceptable tender scores 90 points for price;

(ii) for contracts with a Rand value equal to or below a prescribed amount **[a maximum of 20 points may be allocated for specific goals as contemplated in paragraph (d)]** the achievement of specific goals as outlined in paragraph (d) may constitute a tiebreaker mechanism or constitute a maximum of 20 points

[provided]: Provided that the lowest acceptable tender scores 80 points for price;” and

(b) by the substitution in subsection (1) for paragraph (d) of the following paragraph:

“(d) the specific goals may include [—

(i) **contracting with persons, or categories of persons, historically disadvantaged by unfair discrimination on the basis of race, gender or disability;**

(ii) **implementing the programmes of the Reconstruction and Development Programme as published in Government Gazette 16085 dated 23 November 1994]** contributions made towards the achievement of the following Sustainable Development Goals:

(aa) No poverty;

(bb) zero hunger;

(cc) good health and well-being;

(dd) quality education;

(ee) gender equality;

(ff) clean water and sanitation;

(gg) affordable and clean energy;

(hh) decent work and economic growth;

(ii) industry, innovation and infrastructure;

(jj) reduced inequalities;

(kk) sustainable cities and communities;

(ll) responsible consumption and production;

(mm) climate action;

(nn) life below water;

(oo) life on land;

(pp) peace, justice and strong institutions; and

(qq) partnerships for the goals contemplated in items (aa) to (pp);”.

Amendment of section 5 of Act 5 of 2000

3. Section 5 of the principal Act is hereby amended—

(a) by the substitution for subsection (1) of the following subsection:

“(1) The Minister [**may**] must make regulations regarding any matter that may be necessary or expedient to prescribe in order to achieve the objects of this Act[.], including—

(a) details of what will constitute a contribution towards the achievement of a Sustainable Development Goal; and

(b) a framework outlining how contributions made towards the achievement of Sustainable Development Goals are to be measured and points allocated.”; and

(b) by the insertion after subsection (1) of the following subsection:

“(1A) Any regulation or notice issued by the Minister in terms of this Act must be tabled in the National Assembly for consideration prior to publication or gazetting.”.

Repeal and amendment of laws

4. The Acts referred to in the first and second columns of the Schedule are repealed or amended to the extent specified in the third column of that schedule.

Transitional provisions

5. (1) Notwithstanding section 4, the Minister and the Commission referred to in section 1 of the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003) must, within three months of the commencement of this Amendment Act, conduct and complete an analysis of all primary and secondary legislation, code, policy or similar measure developed, which refers to or is issued in terms of the Broad-Based Black Economic Empowerment Act, 2003.

(2) The Minister must table a report on the analysis contemplated in subsections (1) in the National Assembly within 30 days after the finalisation of the analysis.

(3) After the lapse of 12 months from the commencement of this Amendment Act—

(a) the Minister; or

(b) the relevant minister responsible for the administration of any of the primary legislation, secondary legislation or code, policy or similar measure contemplated in subsection (1),

respectively, must, with the introduction of any new primary legislation or secondary legislation, propose the repeal of any reference to the Broad-Based Black Economic Empowerment Act, 2003 in any such primary legislation, secondary legislation or code or similar measure or replace it with the Sustainable Development Goals where appropriate to do so.

Short title and commencement

6. This Act is called the Preferential Procurement Policy Framework Amendment Act, 2023, and comes into operation on a date fixed by the President by Proclamation in the *Gazette*.

Special Rule 10.19 is amended so as to provide as follows:

PRASA Sub-Fund Special Rules**10.19 ANNUAL INCREASE**

- 10.19.1** The benefit received by a **Pensioner** or **Dependant** shall be increased by 2% (two per cent) compounded annually, for each completed year in respect of which the benefit has been or is received: Provided that in the case of a **Dependant**, the 2% (two per cent) enhancement of the benefit shall be calculated from the date on which the benefit first became payable to the **Pensioner**.
- 10.19.2** Subject to **Special Rule 10.19.3**, the **Sub-Fund Board** shall have the discretion to:
- 10.19.2.1** review the level of **Pensions** being paid by the **Sub-Fund** from time to time and may direct that **Pensions** be increased. Any increase in **Pensions** shall be paid in terms of **Pension Increase Policy**, provided that:

10.19.2.1.1 a guaranteed minimum increase of 2% (two per cent) shall apply;

10.19.2.1.2 any increase to **Pensions** above the 2% (two per cent) minimum increase referred to in 10.19.2.1 shall be subject to affordability, as determined in accordance with the **Pension Increase Policy** and the approval of the **Employer**; and

10.19.2.1.3 the increases shall be payable from the date stipulated in the **Pension Increase Policy**; and/or

10.19.2.2 Pay additional ad hoc bonuses to **Pensioners** or **Dependants** from time to time.

10.19.3 The increase in **Pensions** and/or the payment of ad hoc bonuses as provided in **Special Rules 10.19.2** shall be subject to:

10.19.3.1 The **Sub-Fund** being able to afford such increases and/or payment of ad hoc bonuses according to the discretion of the **Sub-Fund Board**; and

10.19.3.2 the actuary's written confirmation that such increases and/or payment of ad hoc bonuses are affordable by the **Sub-Fund**; and

10.19.3.3 the written approval by the **Employer**.
